General Terms & Conditions :-

1. The bidder / firm must have minimum two year experience of successful execution of installation work of Integrated Alarm Systems in Govt. /PSU/ Nationalized Banks / Private firms.
2. The company/ firm/ bidder should have valid GST number.
3. The contractor should be an income tax payee and should have filled income tax return for the last assessment year.
4. The Contractor / Vendor will be responsible for any injury to their workmen during performing the replacement / maintenance work etc.
5. The vendor/ contractor will maintain a data log sheet of all Integrated Alarm Systems like details location, type and due date for visit etc.
6. Payment for installation of new Integrated Alarm System will be made after verifying its working/ performance by the Branch Manager/ Officer-in-charge after obtaining permission from Head Office.
7. The authorized person of the eligible firm/ company shall sign in all the pages of the application with seal of the company/ firm.
8. Earnest money in shape of Demand Draft of Rs.50000/- in favour of **Punjab Gramin Bank** payable at Kapurthala is to enclosed with the Technical Bid.
9. Incomplete tenders will be summarily rejected. There should not be any cutting or overwriting on tender while quoting the rates. All erasures and alterations made while filling the tender must be attested by initials of the tenderers.
10. Each of documents should be signed by the contractors or by a partner who has the necessary authority on behalf of the firm submitting the tender in token of his/their having acquainted himself/themselves with the general conditions of contract. Any tender with any of the documents not signed will be rejected.
11. Punjab Gramin Bank reserves its right to reject any / or all the applications without assigning any reasons whatsoever.
12. In case of any dispute, the decision of the Chairman shall be final and binding.
13. **Validity of contract for rates (without GST) will be for one year.**
14. Sealed Tenders should reach Head Office, Kapurthala on or before 14.06.2018 (up to 02.00 p.m.). Tender received after 14.06.2018 (02.00 p.m.) will be rejected.
15. Tenders will be opened at 03.00 p.m. in our Head Office, Kapurthala on 14.06.2018.
16. Bidder can depute his representative to our office on 14.06.2018 at 03.00 P.M. to witness tender opening process. The payment of AMC will be made on half yearly basis from Head Office.
17. TDS will be deducted (if applicable).
18. The engineer will visit the branch on receipt of complaint from the branches/offices of bank, the same will be attended by the trained technician/service engineer of the vendor within 48 hours, and otherwise penalty at the rate of Rs.200 /- per day will be charged.

Technical Bid should be inserted in envelope 'B' and Financial Bid in envelope 'C'. Both the envelopes should be sealed and inserted into a third envelope 'A' which should also be sealed. Envelope should be marked as under:
